29th Annual Creek Cleaning – March 7, 2020

The Bouldin Creek Neighborhood Association's Annual Creek Cleaning will take place on Saturday, March 7, 2020 in conjunction with the Austin Park Foundation's It's My Park Day celebration. (Rain date: March 14)

Since 1991, neighbors have met once a year to collect trash in both East and West Bouldin Creek. Together we have removed car parts and tires, carpets and appliances, small electronics, cans, bottles and plastics as well as mountains of Styrofoam fast food containers and cups. In addition, many pieces of found art went home with their happy finders.

We have been keeping up with trash both in Nicholas Dawson Park and in the West Bouldin Creek Greenbelt throughout the year; however, with recent rains, a lot of debris has swept downstream in both places. We are also looking to remove some more Nandina and Cats Claw from the greenbelt, at least in areas that are relatively poison-ivy-free.

We'll meet at 8:30 am at the entrance to Nicholas Dawson Park on the corner of Gibson and South First for coffee and snacks provided by neighborhood restaurants, then send teams of people to different parts of the two creeks. Around 11:30 am we meet back in N. Dawson Park for lunch, again courtesy of our business friends.

Gloves and trash bags will be provided. Please dress in long sleeved shirts and long pants to guard against possible contact with poison ivy and wear sturdy shoes. Be prepared to get muddy and dirty and have a very good time. Kids, dogs and family friends welcome.



President's Message

Here Comes Code NIMBY

2020 is shaping up to be an ugly year for politics, including at Austin City Hall. An aggressive yet narrowly-targeted re-write of the Land Development Code is being hawked by the Mayor and six of Austin's ten Council members as a miracle cure for the entire town. Increasing density & chopping trees in other neighborhoods in other districts will somehow be the panacea that provides affordable housing and environmental protection for all of Austin, these politicians tell their constituents - just not in their back yards.

NIMBYism - the "not-in-in-my-backyard," beggar-thy-neighbor mentality - has become the defining characteristic of the current Land Development Code proposal. Six Austin Council members are happy to drastically increase building size and reduce parking availability and cut down trees in other neighborhoods as long as their districts go relatively unscathed. Sure, doing something about affordability and the environment is important - just in other districts. So it goes.

Bouldin's Council member Kathie Tovo proposed several amendments to make these changes more fair and equal for everyone in Austin. While other Council members voted against providing fair, equal treatment for all Austinites, they did support at least one amendment giving a few super-affluent neighborhoods a break. Presumably that check is in the mail. So it goes.

Speaking of money and politics, 2020 will also likely see the Council vote to drastically increase building height for the new owners of the Statesman site without making sure the City is adequately compensated for that give-away. In June 2016, Council adopted the South Central Waterfront Vision Plan, which envisions more affordable housing, connectivity, green spaces and great streets as the waterfront is developed. However, more than three years later, Council STILL has not implemented the development, financing, and regulation frameworks needed for the Waterfront Plan to become reality. Developer lobbyists will argue that the Council should prioritize up-zoning more waterfront tracts ahead of implementing the comprehensive Waterfront Plan. And Council will probably agree, because, well, money and politics. So it goes.



Not-so-fun fact: the narrowest sidewalks in Brown Sector are a mere 35 inches wide. As many of you are aware, they both occur on the stretch of South 1st adjacent to the Viewpoint Condominiums. One segment of sidewalk is narrowed due to a tall retaining wall, while the other is constricted by an elevated concrete platform containing a utility access hole. Both sidewalks are precariously adjacent to vehicular traffic traveling at, and often exceeding, 35 miles per hour. Conflicts between pedestrians, scooters, cyclists, and cars are frequent. In addition, the sidewalk is not accessible for people who use wheelchairs.

South 1st is a major urban corridor used by thousands every day. Why is this dangerous sidewalk acceptable in a city of almost a million people?


